BACK TO SCHOOL

For the last two years, the SHCA Education Committee has concentrated on the enrollment problems at Penn Alexander School (PAS) and the fact that the school cannot accommodate all the children in the catchment area who want to attend at various grade levels. This is a major issue that may be facing our community for years, and we have been in regular communication with the School District, the University of Pennsylvania and PAS, fighting for neighbors to have a voice in the decisions that are made. This fall, despite significant worry to the contrary, every child on the Penn Alexander waitlist for kindergarten was offered admission. We are participating in the creation of a newly established School Advisory Council at PAS; an SHCA delegate serves on the council as the community representative.

Our Education committee has also been part of the debate over the school funding crisis as it affects all Philadelphia public schools. We called on city and state officials to find a way to provide additional funding to the Philadelphia public schools, and participated in advocacy efforts of other community members

APPLY TO SPRUCE UP YOUR BLOCK

This year, UC Green's director, **Sue MacQueen**, joined our board and has brought new energy and expertise to our Greening Block Grant Program. To improve the streetscape in our neighborhood, Spruce Hill's Greening Block Grants encourage the planting and maintenance of street trees, the creation of tree lawns by removing concrete, and the installation of front gardens.

Grants up to \$500 for a single block and up to \$1,200 for cooperating adjacent blocks require a dollar-for-dollar match of the grant amount through volunteer "sweat equity," in-kind materials or services, or by cash donations. Recently a grant was awarded to spruce up the tot lot at the corner of 45th and Sansom.

Bringing Crucial Tax Information to Neighbors

In March 2013, hundreds of neighbors came out to an informational town hall meeting on the property tax overhaul known as the **Actual Value Initiative (AVI).** For many area residents this will mean higher tax payments in 2014.

Topics discussed included the Homestead Exemption and concerns about how the new assessments were made.

The panel included Chief Assessment Officer Richie McKeithen; Councilwoman Jannie Blackwell; economist Dr. Kevin Gillen; and moderator and reporter Patrick Kerkstra.

The heavily attended event was organized by several neighborhood associations, including Spruce Hill, Cedar Park Neighbors, Garden Court, Walnut Hill, and Woodland Terrace.

DEVELOPMENT IN SPRUCE HILL

Fine Wine & Good Spirits Shop, S. 43rd and Chestnut Streets

After several years of discussion, debate, petition drives, and community meetings, the long-delayed wine and spirits shop is now a reality. The store is clean and bright, the staff pleasant and helpful, and the area safe and welcoming. A security arrangement, negotiated by Spruce Hill zoning with the property owner and the state and the University City District, provides car and bike patrols during the store's operating hours. Our thanks to all whose efforts made this neighborhood addition possible.



University City Chinese Christian Church, Corner of S. 45th and Walnut

When the Chinese Christian Church approached the association about purchasing this two-story cinder block building and converting it into a place for worship and classroom instruction, we engaged in a constructive conversation about changes to the exterior facade, which – to put it mildly – were in need of a serious aesthetic upgrade. We also held a series of meetings with the site's neighbors in the nearby Mosque and with area businesses to facilitate the blending of the richness of cultures that mark our community. There is general agreement that the church is a welcome neighborhood addition, both in its physical presence and for its architectural exterior enhancements.



4507 Kingsessing Avenue

This site, once a vacant lot due to a building collapse, now houses a residential structure that emerged from a series of meetings that stretched out over two years. The community worked with a responsible developer who made a good faith effort to satisfy the concerns of neighbors to construct a building that would harmonize with existing structures

PENDING DEVELOPMENTS

4224 Baltimore Avenue

No site in Spruce Hill has generated more speculation over the past few years than this empty lot across the street from Clark Park. The lot is owned by a corporate entity in New York and was given an "as of right" permit to construct 92 units with 6 parking spaces under current zoning. Two locals - Omar Blaik and Tom Lussenhop – persuaded the owner to give them an opportunity to serve as developers for 4224 through community engagement to see what alternative project might better serve the area's needs. The development team, u3Ventures, decided to engage the community from the ground up by inviting all interested parties to a series of community meetings to discuss possibilities for development. Three community meetings featured discussions around design and massing, housing components, commercial operations and transportation and parking issues. By the end of the process a general consensus emerged that housing should be varied, with space reserved for a set number of accommodate condominiums to neighborhood "down sizers" who wished to remain in University City and who looked forward to the prospect of living in a mixed use development. Spruce Hill is now waiting for the development team to finalize plans for the next stage - one in which the association's zoning committee will hold open meetings to examine and comment on the project's plans and offer its recommendation to the Spruce Hill board. We will keep you posted.

HUB 2, S. 40th and Chestnut

This project was first approved by the zoning committee in 2008, but financing became an issue in the face of the recession. Certain modifications were made in design and size in 2013, and the zoning committee gave its approval with a letter of understanding signed by the parties stipulating that discussions on exterior facade materials would continue to the satisfaction of both.

Corner of S. 40th and Pine

This seemingly never ending development continues on. After much negotiation, the Spruce Hill board approved the demolition of the existing vacant structure and the construction of a five story residential student housing complex. The demolition and zoning variances were approved by the Historical Commission and the Zoning Board of Adjustment respectively, but opposed neighbors have challenged both decisions and the matter is now tied up in the courts. In October, our zoning committee received a preliminary outline of a new proposal from the site's developer, and the committee will discuss the plan at its next scheduled zoning committee meeting on Monday, November 25. Interested parties are invited to attend to ask questions and offer comments.

Corner of S. 43rd and Sansom

The committee spent several sessions working through the details of a proposed four story housing development on this currently vacant lot. In addition to requesting significant architectural design changes to the structure, the committee insisted on having a commercial component

added to this development with first floor retail space along the 43rd Street side. The property owners expect to break ground next Spring with occupancy scheduled for June 2015.

Watusi II, Corner of S. 45th and Locust

This bar has been a source of neighborhood discontent for some time, negatively impacting the quality of life for those living in the surrounding community. Spruce Hill pulled together a meeting in August with neighbors and city officials to address the problem, and I am pleased to report that city officials have been tremendously supportive and helpful. The bar is currently closed due to the owner's failure to be current in payment of his business license, and we are in touch almost daily with city personnel to monitor future happenings. There will no doubt be "ups and downs" with this property and the other two bars owned by the same individual (Watusi I and Third World Lounge), but we are determined to stick with this until the community no longer fears that peace and tranquility is just a momentary state.

Other Items

We have a number of additional items on our zoning horizon, but they are in the early formative stages. They include housing unit construction, tattoo parlors, and culinary related operations. More to come.

and organizations. We have been communicating with the neighborhood via the SHCA list-serve about ways that neighbors could become involved in advocacy efforts.

We closely followed the PSD decision to close the Wilson School and transfer some of its students to Lea. Many of you may recall that the Education Committee spearheaded a fund-raising drive several years back to install muchneeded play equipment at the Wilson playground. SHCA has been working

with the West Philadelphia Coalition for Neighborhood Schools and the district to have this play equipment reinstalled at Lea as part of the improvements to Lea's playground.

Finally, thanks to the generous support of the Spruce Hill community, we raised about \$2,500 in a special appeal to help PAS replace a large window that was apparently the victim of vandalism over the summer break. With the school funding crisis, PAS was having trouble paying for it and

requested our help. We felt it was important not to let a single act of vandalism jeopardize the use of PAS's grounds as a community play area after school hours. The window has been fixed - our thanks to all who contributed!
