# SHCA Board Meeting, June 11, 2013

**GUEST SPEAKER:** Jon Potter, Economic Development Manager, UCD. Jon's role is new, but was previously the quarter manager. Potter's new position is as corridor development for both Lancaster and Baltimore Avenue. He's been asked to think about economic development more broadly which includes things like start up, thinking about the neighborhood retail environment corridors more broadly. His role overlaps b/c of retail development and recruitment. Keeps a running list of the kinds of businesses we want to see here and the types of businesses who want to be here.

Q- Barry Grossbach; are you working with the marketing survey from previous years? A- Yes. There was a survey looking at 3 categories of retail and where there is room for more, and also getting feedback from the community. That study starts me with a list of 40 retailers in the area and I'll be building off of that.

Q- Lee H. Can you talk about the role you play with CDCs in the area?

A-I've met with most of the significant groups that are working in the area. There are overlaps with many groups and we respect those boundaries. I've tried to open up communication lines with the other groups.

Q-Eric S. - Can you talk specifically about the categories of businesses you have in mind? A- Food and restaurants, neighborhood good s and services, infrequent retail like a clothing store. One of the outputs of the study was locating areas for possibilities for these businesses. Q-Eric S. - How are you making these judgement calls?

A- I haven't done that yet. I've had probably 80 1-1 meetings getting to know the area. My feeling is that one of the things we hear from the neighborhood is that we prefer independent retailers. If we can drum up interest so that there is more demand for space than there is,we can drive the market. I don't think there's a problem with having a waiting list for business
