Committee Updates

Zoning Committee (Barry Grossbach):

UCD received approval from Art Commission on first go round for the Portal Project. UCD has been denied zoning. Brett Feldman will represent UCD before the ZBA (will recuse before Spruce Hill) and will get a hearing date shortly. The RCO meeting will be next. 4 RCO's are involved. Spruce Hill is the convening RCO. Woodland Terrace has not hired an attorney to represent them on the portal project. An individual on the block has contracted for legal representation. The block is not involved. Barry described the outdoor seating at the project. RCO meeting may be last week in February or first week of March. The site is currently zoned as residential.

17 and 19 S. 44th and 46th streets. 44th and a property on Ludlow Street. Owner plans to build as of right on 4 sites and wanted to setup a meeting with Barry. Barry suggested that he come our next zoning committee meeting and the owner has agreed. Owner is trying to coordinate with Orens brothers. Brings radical changes to the north side of Spruce Hill.

Zoning Committee has approved the Hookah Lounge on the 4400 block of Chestnut with some restrictions.

Ronald McDonald house expansion will begin with the demolition of the two houses on the side of Ronald McDonald house in February. They have invited neighbors to a lunch to come hear the plans.

UC District has received \$750,000 to support landscaping and other community rehab projects.

West Philly High project is going forward.

46th and Spruce - There will be a meeting soon. A neighbor has hired an attorney and has not been in touch.

Demolition has started on a house on 45th street. Board discussion on ability of people to pull demo permit. We should be documenting before and after shots of these properties.

Crosstown Coalition (Monica and Barry):

Asking for approval of memo related to land use - institutionalize civic input in the land use legislation process. Wants to make sure that communities are in on the ground floor on land use legislation. Barry thinks that #6 on the memo is important in terms of keeping communities informed. John Potter - is this memo building on a system of RCO's that doesn't function well already? Barry - more of a notification process is proposed here

Physical Therapy will open behind PFCU on 5000 Block of Baltimore w/ some sort of gym facility (not in spruce hill)

4300 Baltimore update? want a restaurant facing the park; Penn Vet might want to have a facility there; 2nd floor will be gym (nothing about this is new).
