## **Zoning** - Barry Grossbach

Barry talked about broader issues facing zoning and rezoning in Spruce HIII.

He talked about the CMX zoning issue – He attended a zoning committee meeting at Walnut Hill where they discussed developers wanting relief from being required to do commercial CMX2. Pushing for commercial at one location.

Barry also talked about the north side of spruce hill along Market St. Area needs development and planning. Apartments are gated and the surroundings discourage people from walking or being on the street. We need planning. The dead zone is a big prob with the area in general. No

planning by anyone about Market Street. Elwin Institute is on sale, under contract with drug abuse recovery center. Nobody is doing anything. Need to get movement on planning this area.

4224 baltimore – attended meeting with lawyer and developer who wanted administrative approval from SHCA Zoning. Zoning asked for more information to sign off. Will be coming back with more info about the proposed development.

Barry met with Councilwoman Blackwell for support on changing some zoning codes in Spruce Hill. She supports change some zoning codes – multi family to RTA1 should be RSA. Blackwell instructed City planning to get on board but the city planning uncovered errors in some rules – back to drawing board.

Blackwell wanted information about how we felt about the bike lanes that she is skeptical about.

**Education** - Sylvia Hammerman-Brown/Monica Calkins SAC meetings open to the community. Anything can be added to the agenda.

Laura Line – outdoor space – meadow project was a great community project – 3600 meadow plants. Went well.

The waitlist. Monica will put a SAC agenda item as to whether or not SDP letters that went out to waitlisted kindergarteners guaranteeing a place in 1<sup>st</sup> grade was a mistake. Mary Ellen mentioned that this was the case with her neighbor.
