June 2021 Meeting Minutes

May 2021 Minutes Approved

Guest Speaker: Jeannette Brugger, Bicycle & Pedestrian Coordinator, City of Philadelphia

- Review of projects for Chestnut and Walnut Street, and West Philadelphia Re-paving and Complete Streets Safety Plan
- Public Survey was used to gather public input on priorities: https://www.surveymonkey.com/r/cwsurvey2021
- Re-paving to take place under PennDOT on more than 6 miles of road.
- The goals of the project are to:
 - o Calm traffic by decreasing speeding, weaving, and aggressive driving.
 - o Create shorter and safer pedestrian crossings.
 - o Improve parking and loading operations.
 - Increase safety for people riding bikes by separating them from motor vehicle traffic.
 - Reduce illegal parking behaviors, like double-parking and blocking the crosswalk.
- As part of this project, City staff and community stakeholders will discuss safety issues and improvements along the corridors.
- Street re-paving to take place on:
 - Chestnut Street from 63rd Street to 34th Street
 - Walnut Street from Cobbs Creek to 22nd Street
- Project planning considered function, lanes, crossings, bus routes, bike lanes, parking, and loading rules
- Based on data and community feedback, they do to want to just re-pave and put back what currently exists
- Streets to be smother, easier to understand, with safer crossings, calmer traffic, safer for bikes, and keeps traffic moving
- Survey to be published on June 9, 2021.
- Project Timeline has a completion date of Spring 2022

Q: Have the universities committed to supporting the project?

Q: Is there any plan to create a safer pedestrian crossing between the trolley portal and The Woodlands?

A: The guest is aware of the crossing, but not of plans to work on a crossing. They did say that the trolley lines make the the crossing more complicated to put in a traffic signal
