June minutes – motion to approve – seconded, approved

Committee Updates

- Executive Committee (Eric Santoro)
 - Outreach support
 - Exec Approved request for \$300 for Halloween Block Party reporting this to the board
 - Exec Approved request for PIC \$300 reporting this to the board
 - Annual meeting
 - Will be held at PAS
 - Speakers
 - Jenine reached out to talk to the panel; Aaron Munch moved to Germantown; will reach out to people who live in historic districts; open forum. Barry – if you go this route, really important to have a meeting in the neighborhood where the district will be – not at PAS, where the district is not going to be. Woodland Presbyterian Church has been beautifully restored, got plenty of chairs, in the area where talking about creating a first historic district. Separate from the annual meeting. Invite people to come and ask questions. Do it as part of the annual meeting. Who can answer the questions? Ask Amy from the historical society – people have heard the speeches – they have heard the presentations. Get feedback from people. Concerns about having open forum right before the historical meeting- but we need to have meetings. Coming after the house tour – to help finance the district – appropriate to have something at the follow up. Professor at Penn – house tour of Society Hill. Randall Mason – professor of Historic Preservation. Rely on Powelton? Lean on them – useful example of neighborhood like ours. Ask Poulin – what was

the nature of the meetings, what did they do. Jenine will contact. Neighbors who live in historic district and what it was like for them. Move annual meeting to Woodland Presby. Chester avenue minidistrict – people who went through it - and their experience – Amanda Benner will know – Barry will get in touch. Rob Harker and Bill Renaldo. It was done in Spruce Hill. Object lesson for people.

• Historical Preservation Committee (Jenine Sanzari)

- o No updates on the submission itself CC working to button up the final submission
- Evan prepared a letter for costs of donations that will send to list serve Sylvia, Julie and Barry make sure that everyone on the board has donated to this cause. Any questions around that let Jenine know? Is there a list? Barry monitoring PO box, everything going into Trust account. If you go out and ask people to contribute, you have to be able to say that everyone on its board is a contributor. Can be any amount.

- University City Historical Society house tour on November 4th four hour commitment, any board members who are home and available volunteer your home. 7 houses on the tour so far volunteer if you can.
- **Zoning** (Barry Grossbach) not much going on,

- have approved a 6 unit building next door to the chapter house on 42nd street, was zoned for 2-family, the 6 unit zoning lapsed, met with architect and owner, long term member of the resident, has also taken care of some beautiful Victorian homes, very deep building 403 s 42nd street approved.
- O Approved continuation of a 5 year agreement for a property at 4030 spruce as a fraternity house. Long time family residence then sold to penn. It has been kept up.
- 43rd and Baltimore 135 units got a hard hat tour up to the roof pleasantly surprised windows open swing out upper floors facing east, looking at CC skyline facing west looking down at tops of trees in clark park. Parking is such interior not enclosed in a way that causes it to be diminished. Nice roof deck, lots of amenities. Commercial spaces on the ground floor are quite spacious struggling to find commercial interest. Interest rates high, cities taking a hit in terms of commercial space. Clarkville was for the third or 4th time attacked with broken windows, graffiti door. Working very hard to find the proper tenants know what we don't want hope to start leasing in January some apartments are 2-level. Rents? As much as they can get. Times are a-changing. How many parking spaces? Not sure there are a lot. Experience is that the people do not have cars lots of people walking to the university/HUP. Whole Foods? NO. Trader Joes took a look at a facility where there was a Rite Aid, they said no.

• Safe Streets & Commercial Corridors (Evan Johnstone & Eric Santoro)

- O Survey and taking the next steps make it available to others post-survey to try to figure out how we can effectively communicate it.
- o There is a report now. Take some elements from that − make some slides, and present to the annual meeting.

- Crime in the neighborhood how we can help and be supportive Evan is talking to Nicki the community liaison at Penn – hasn't attended a meeting lately – they do weekly crime reporting – take a look at the trends – might be able to help address in some way
- O Davis Pharmacy had explored a town watch wants to start a town watch can get an information from that office and give that to him – UCD ambassadors – go up to 50th street - they are ours. They will do a training – town watch. UCD has statistics on everything that is happening. Problem with policing in the city right now. Tony talking to Town Watch Integrated Services – organizes, trains, and provides equipment to residents who want to be a part of Town Watch groups in their community.

• Education (Becca Geller-Puchalsky) –

- street safety adventure going around; speaking with a lot of people, attending a lot of meetings a lot of paths to get around try to apply for a pedestrian plaza purchasing/installing planters like 48th and Baltimore. Walked around with city leaders who suggested. Asked to make a drawing (!!) what is the infrastructure that you want. Showing the red/highlighted spots looking for suggestions. Would need a letter of support like for the slow zone traffic calming is coming.
- O Neighbor whose kids didn't get into PAS -3^{rd} and 1^{st} grade, and also not Lea! Maybe take this up again next year. Routine updates on the wait lists chart of enrollment so we can keep an eye.
