## Summary

## **SHCA Meeting Minutes and Updates**

In the meeting, Becca led the discussion, starting with the approval of the January meeting minutes. The meeting then shifted to committee updates, with Barry expressing concerns about the privacy of certain information and requesting it be discussed in an executive session. Dominique London from UC Green then presented about the work they've been doing with Laura, including a design charrette pilot program and partnerships with various organizations. The conversation ended with Becca thanking Dominique and preparing for Barry's presentation on the Spruce Hill Trust.

#### Spruce Hill Community Association and Trust

Barry discussed the unusual arrangement between the Spruce Hill Community Association (a 501(c)(4) entity) and the Spruce Hill Community Trust (a 501(c)(3) entity). He explained that the Trust was formed to allow the Association to raise funds and receive tax-exempt donations. A discussion under executive session ensued, ending with an action item for Barry and Richard to meet separately to discuss a proposal regarding the Trust's finances for the SHCA board's consideration at an upcoming meeting.

## **Community Outreach and Historic Districts**

Barry emphasized the importance of community outreach and engagement in the northeast and northwest quadrants before submitting historic district documents to the Historical Commission. He warned that without proper communication and support, the initiative could face significant opposition. Tony agreed with Barry's concerns. SHCA discussed the need for on-the-ground movements in the north and northwest quadrants for the next application. The conversation ended with a discussion on the importance of the Spruce Hill Community Association owning the historic district initiative.

## Historical Preservation Committee's Appeal and Fundraising

The Historical Preservation Committee discussed the ongoing appeal against the city and the need for awareness and fundraising for the next submission of the northeast and northwest districts. Janine proposed forming a subcommittee to brainstorm ways to raise awareness and garner support. The committee also discussed the timeline for the submission of September 2025, which may shift due to personal challenges faced by their consultant. The committee also discussed a zoning meeting involving 4,400 Market Street and the issue of Saxby's coffee shop lease termination, with the dental school planning to expand. Barry emphasized the importance of community involvement in these issues.

## Penn's Real Estate Operations Discussion

In the meeting, Barry agreed to ask Ed Datz from Penn's real estate department to be a guest speaker at the next board meeting. Evan committed to attending the Public Safety Zone 3 meeting and planned to provide an update on the Woodland Avenue project. Becca also mentioned a Zoom meeting about the Route 36 trolley modernization project, which she would send out to those interested. Tony discussed the need for a system to track requests for using the community center's space, and it was suggested to reach out to Chris Bole for more information.

## **Spruce Hill Community Association Updates**

The board discussed several topics related to the Spruce Hill Community Association. They considered asking groups using their space for donations to cover expenses. Tony mentioned the need to update legal forms and user group records. The recent Open House and Book Sale event was successful and seen as a model for future outreach. The board also discussed preparations for the upcoming Mayfair event, including securing permits, booking music, and seeking sponsorships. They considered strategies for fundraising, including board member donations to support the historic district initiative. **Next Meeting:** Tuesday, February 11th, 2025
